Prior to joining Casdin Capital, Shaun Rodriguez was recognized as one of the 2014 Rising Stars of Wall Street by Institutional Investor. Each year, Institutional Investor asks buy-side investors to identify equity analysts that deserve to be recognized as up-and-comers—analysts who have been publishing research for less than three years in any region—who seem destined for greater glory.



Institutional Investor tabulates the votes and declares the analysts the Rising Stars of Wall Street Research. Respondents may name only one person per sector; to qualify, analysts must meet a minimum vote count and cannot have placed previously on any research team. The Rising Stars are not ranked; rather, they are listed alphabetically by sector, as all analysts who meet the eligibility requirements are awarded the designation. Analysts must be certified pursuant to Regulation AC to be recognized as Rising Stars in all research sectors. The 2014 survey drew responses from nearly 620 individuals at more than 350 firms that collectively manage some \$5.9 trillion in U.S. equities.
